Who we are

At FINBRIDGE CONSULTING GROUP (“we”, “us” or “our”), accessible at www.finbridge.co.ke, one of our main priorities is to respect and protect the privacy of our visitors and clients. We are committed to protecting the types of personal information that are collected and recorded by FINBRIDGE CONSULTING GROUP and how we use it through this Privacy Policy.

Please read this Privacy Policy and revisit/review this page from time to time as changes may be made at any time. Any amendment to this Privacy Policy will automatically take effect on the date set out and posted unless otherwise date and time are specified.

What personal data we collect and why we collect it

FINBRIDGE CONSULTING GROUP follows a standard procedure of using log files and collecting your personal information that governs your access to and usage of www.finbridge.co.ke, its content, functionality and services offered, whether as a visitor or client.

When accessing the Website, the visitor’s or client’s information is logged in various ways and for different purposes, both automatically and through voluntary actions.

We use voluntary information to conduct genuine business interests, provide our services, and contact you about the services in which you have expressed interest. The information voluntarily collected by log files through filling out forms on the website and/or communicating with us via contact forms may include name, address, telephone number, email address, type of business, size of business and locations.

We use automated technical information about your visit for statistical data, analyzing trends, tracking users' actions on the website, administering the site, diagnosing problems with our server, and administering the Websites and gathering demographic information.

CHILDREN INFORMATION UNDER THE AGE OF 13

FINBRIDGE CONSULTING GROUP Website is not intended for children under the age of 13 and does not knowingly collect any Personal Identifiable Information. We encourage parents and guardians to observe, participate in, and/or monitor and guide their children’s online activities and interests.

COOKIES, DIGITAL MARKERS AND OTHER WEB BEACONS

The information automatically collected by log files includes internet protocol (IP) addresses, browser type, Google Analytics information, Internet service provider (ISP), platform type, operating system, date/time stamp, referring/exit pages, and clicks. These are not linked to any information that is personally recognizable and cannot be used to identify you individually.

Like any other website, uses 'cookie'. www.finbridge.co.ke Cookies are small packets of data that often include anonymous unique identifiers. Cookies store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. When you visit a website, that site's computer asks your computer or mobile device for permission to store this file in a part of your hard drive specifically designated for cookies. The information is used to optimize the users' experience by customizing our web page content based on visitors browser type and/or other information.

You may choose to disable the cookies from your computer or mobile device through the relevant settings on your internet browser. If you decide not to accept cookies from us, the website may not function to its best capabilities.

DOUBLECLICK DART COOKIE/THIRD-PARTY ANALYTICS

What third parties we receive data from

Google is one of the third-party vendors on our site, used to evaluate your use of the website, analyze performance metrics, collect demographic data, and analyze other information related to the Website and mobile internet usage.

Google Analytics also uses DART cookies, to serve ads to our site visitors based upon their visit to www.finbridge.co.ke and other sites on the internet. Contact forms

Cookies

The Website provides various forms for users to provide information. We collect information that users provide by filling out forms on the Website, communicating with us via contact forms, and providing comments or other feedback via the Website.

We use the information you provide to us to deliver the service, improve our overall performance, and provide you with offers, promotions, and updated information.

If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you visit our login page, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser.

When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed.

If you edit or publish an article, an additional cookie will be saved in your browser. This cookie includes no personal data and simply indicates the post ID of the article you just edited. It expires after 1 day.

Embedded content from other websites

Articles on this site may include embedded content (e.g. videos, images, articles, etc.). Embedded content from other websites behaves in the exact same way as if the visitor has visited the other website.

These websites may collect data about you, use cookies, embed additional third-party tracking, and monitor your interaction with that embedded content, including tracking your interaction with the embedded content if you have an account and are logged in to that website.

Analytics

Who we share your data with

As a general rule, we do not sell, rent, lease, or otherwise transfer any information collected whether automatically or through your voluntary action.

Your contact details will not be seen, shared, or sold by/to anyone.

Your information is only visible to us as Finbridge Consulting Group Consultants.

Your information and contact details remain private and confidential.

We may disclose your personal information to our subsidiaries, affiliates, and service providers for the purpose of providing our services to you.

We may disclose your personal information to a third party, in good faith when required by the law as a result of a court order, subpoena, or warrant, including a lawyer. In addition, we may, subject to applicable law, voluntarily provide information in order to assist in a law enforcement investigation or where the disclosure is necessary to protect our legal rights, our systems, our business, or the rights of others.

How long we retain your data

If you leave a comment, the comment and its metadata are retained indefinitely. This is so we can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

For users that register on our website (if any), we also store the personal information they provide in their user profile. All users can see, edit, or delete their personal information at any time (except they cannot change their username). Website administrators can also see and edit that information.

What rights you have over your data
